#### 6. REPRESENTATIONS, WARRANTIES AND COVENANTS

The Developer represents, warrants, and covenants with Yukon Energy Corporation and/or ATCO Electric Yukon as follows and understands that Yukon Energy Corporation and/or ATCO Electric Yukon is relying on these representations, warranties and covenants in deciding whether to offer an EPA to the Developer:

- 6.1 The Developer has reviewed carefully and fully understands the Rules, the Standard Form EPA and all related documents posted to the SOP Website and has taken legal, accounting, engineering and other professional advice as the Developer considers necessary for it to understand its rights and obligations under the EPA if an EPA is offered to the Developer.
- 6.2 In preparing and submitting this Application, the Developer has not relied on any information given to it by Yukon Energy Corporation and/or ATCO Electric Yukon, whether orally, in writing, electronically or in any other form whatsoever, except information disclosed in the Rules, the SOP Website or advised in writing by the SOP Administrator.
- 6.3 In consideration for Yukon Energy Corporation and/or ATCO Electric Yukon reviewing the Developer's Application, the Developer agrees to the terms, conditions and exclusions and limitations of liability set out in the Rules in effect at the time the Application was submitted.
- 6.4 The information contained in the Application is true and correct in all material respects and there is no material information omitted from the Application that makes the information in the Application misleading or inaccurate in any material respect.
- 6.5 The Developer is duly incorporated, organized, validly existing and in good standing under the laws of the jurisdiction of its incorporation, is registered or otherwise lawfully authorized to carry on business in Yukon, and has full power, capacity and authority to own its assets and to carry on its business as now conducted and to enter into and to perform its obligations under the EPA if an EPA is offered to the Developer. If the Developer is a joint venture or partnership, this representation is true and correct for each of the participants in the joint venture or partnership.
- 6.6 No actions have been taken or authorized by the Developer or any other person to initiate proceedings for, or in respect of, the bankruptcy, insolvency, liquidation, dissolution or winding-up of the Developer or to appoint a receiver, liquidator, trustee or assignee in bankruptcy in respect of the Developer.
- No appropriation, expropriation or seizure of all or any portion of the Project, or the assets required to construct, operate or maintain the Project, is pending or threatened.
- Neither the signing of the EPA, nor the carrying out of the Developer's obligations under the EPA will: (i) constitute or cause a breach of, default under, or violation of, the constating documents or bylaws of the Developer, any permit, franchise, lease, license, approval or agreement to which the Developer is a party, or any other covenant or obligation binding on the Developer or affecting any of its properties, (ii) cause a lien or encumbrance to attach to any of the assets included in the Project (as defined in the Standard Form EPA), other than a security interest granted in respect of financing the design, construction or operation of the Project, or (iii) result in the acceleration, or the right to accelerate, any obligation under, or the termination of, or the right to terminate, any permit, franchise, lease, license, approval or agreement related to the Project.
- 6.9 In consideration for Yukon Energy Corporation and/or ATCO Electric Yukon reviewing the Developer's Application, the Developer agrees that: (A) Yukon Energy Corporation and/or ATCO Electric Yukon has





no liability to the Developer or any affiliates of the Developer for any failure by Yukon Energy Corporation and/or ATCO Electric Yukon prior to the effective date of an EPA to adequately consult with, and/or accommodate, any First Nations in relation to: (i) any decision to offer or not to offer an EPA to the Developer, (ii) the Project, (iii) the Developer's Plant, or (iv) the interconnection of the Developer's Plant to the Transmission System or the Distribution System (excluding matters arising on Yukon Energy Corporation's and/or ATCO Electric Yukon's side of the point of interconnection to the Transmission System or Distribution System); and (B) Yukon Energy Corporation's and/or ATCO Electric Yukon's liability, if any, for any failure by Yukon Energy Corporation and/or ATCO Electric Yukon after the effective date of an EPA to adequately consult with, and/ or accommodate any First Nations in relation to the foregoing matters will be determined in accordance with the EPA as if it was still in effect notwithstanding any expiry, termination, declaration by any order of a court or regulatory authority that the EPA is invalid, void or unenforceable, or any other means by which the EPA ceases to be in effect.

6.10 The Developer has read carefully, and it is in compliance with, the Yukon Energy Corporation and/or ATCO Electric Yukon Contractor Standards for Ethical Conduct which is current at the time of the Application. The Yukon Energy Corporation and/or ATCO Electric Yukon Contractor Standards for Ethical Conduct is available on the SOP Website.
